Statements By Nominees

Alex Gosman (President)

I have been a member of U3A Canberra since 2016 and have served in several volunteer roles for the past six years including leading two courses, planning and organising the Forums, serving as U3A Canberra's representative on the Committee of NSW U3A Network, and for the past three years, occupying the position of Vice President on our Committee. I have also managed the Communications Team for some years.

Lindsay Rae (Vice President)

I joined U3A Canberra in 2018. I served as a Vice President for two years before becoming President in 2022 so have now served in this position three years,

including during the challenging second half of the COVID Pandemic. I have extensive experience in government, non-for-profit organisations and academia.

Andrea Hope (Vice President)

I have served as an ordinary member of the Committee for just short of two years. In that time I have been closely involved in substantial strategic tasks, such as developing a strategy to increase and refresh the membership of U3A Canberra. I have also delivered numerous U3A courses in the arts area and have been responsible for the liaison for programs provided by the National Film and Sound Archives.

I have many years management experience at the senior executive level in the Commonwealth Public Service and, post (semi) retirement, have been closely involved in the arts, including setting up and running an art gallery, establishing an arts trail and co-convening a major arts festival in Gerringong. I also served at as the President of the Kiama Friends of the Library.

Graeme Swift (Treasurer)

If elected, this will be my third year on the U3A ACT committee as Treasurer. I consider that I have added value to U3A's operations through the implementation of a financial package (MYOB) for managing finances and reporting, the introduction of an asset management system to control assets (Asset Tiger) and other improvements to the integrity and responsiveness of the financial elements of U3A management. With the assistance of the new assistant Treasurer (Mary McDonald) we propose an examination of banking arrangements to ensure we are receiving value-for-money. We have other ideas to ensure that U3A's finances and system remain fit-for-purpose and relevant.
